Timeline and Helpful Hints

2017-2018

ESSA Consolidated Application for Federal Funding **Amendment due date** – 6/1/18

We still have approximately 322 amendments that need to be submitted. These amendments are for any applicable final entitlements, carryover and reallocation.

*This includes any late refunds processed after the LEA's last submitted amendment and appeals to MOEs. LEAs that need to come in for their amendments, need to adjust schedule BS6001 and supporting budget schedules, and if applicable, PS3099; PS3101; and PS3107.

ESCs were sent a list of LEAs that still had not amended the ESSA application.

PS3001 will not be in the application next year but if you need to make changes to anything on that schedule before the application closes, please amend now.

In 2018-2019 - It will be a special collection – SC3001.

2018-2019

Application Designation and Certification **(ADC) form will be available** – 6/5/18

If the LEA is eligible for a fund source, the ADC will have the funding amount.

Planning amounts will be available on or about 6/5/18.

New look of eGrants will be available – 6/5/18

Applies to the eGrants home page.

In terms of applications, compliance reports, or program reports, the new look of eGrants only applies to the schedules in the 2018-2019 ESSA Consolidated Application.

ESSA Consolidated Application for Federal Funding **Application available** – 6/5/18

Date functionality of new lines on schedules PS3099, PS3101, and PS3107, available – on or about 7/12/18

LEAs that are using funding transferability will not be negotiated until after – 7/12/18

FAQ: Must an LEA wait to submit their ESSA Application?

Answer: No.

FAQ: Will my NOGA change amounts if I am transferring funds from one fund source to another? For example, if my LEA transfers Title IV, Part A into Title I, Part A. Will the total Title I, Part A NOGA amount change?

Answer: No.

NOTE: If LEA is not using funding transferability, no need to worry about the “new” lines on the schedules.

ESSA Consolidated Application for Federal Funding **Application due date** – 9/4/18

Note: Once a NOGA is received the LEA may not change their funding status.
